Required Material:

1. (Text): *Accounting: Tools for Business Decision Making*, 3rd Edition, by Kimmel, Weygandt, Kieso, (Wiley)
2. WileyPlus - This is an online homework aid. Use the same login that you used in Financial Accounting - ACCT 6192.
3. Calculator (Must be able to perform Time Value of Money Calculations). Finance has suggested the BAII Plus from Texas Instruments in the past but any calculator that calculates Time Value of Money will do. I have used the BA35 from Texas Instruments in the past and it works well also.

- 1 To learn the language of business (i.e. accounting) to be competent in the business community.
 2. To learn to use accounting information to make investment and other business decisions.
 3. To learn to prepare the basic financial statements for a business.
 4. To learn to record business transactions using double-entry bookkeeping.
