Course Description:

Course prerequisites: EDHP 3201 or 6220. This course focuses on exercise principles and practices that have application for professionals that work for the prevention of cardio-respiratory diseases or for the rehabilitation of persons so affected. The conceptual model, theory practice interaction, will be utilized as the method for sequential evaluation of individual course objectives.

Objectives:

Upon completion of the course the student will

- * Understand various cardiac and pulmonary conditions
- * Be familiar with the standardized, acceptable exercise prescription for the condition, if allowed.
- * Be familiar with the conditions that contraindicate exercise prescription
- * Be able to apply theories taught in class to field teaching.
- * Be familiar with a 12-lead ECG harness
- * Recognize a standard ECG pattern
- * Perform an ECG using the Parvo Metabolic Unit

Labs

They will also be responsible to place the leads, and answer the lab questions regarding the ECG. Lab dates will be determined at the beginning of the semester.
