#### Homework:

There will be weekly homework assignments except on the weeks of tests. Assignments will be graded, returned with an answer sheet and discussed in class. Graduate students (enrolled in 5101) will have extra homework sets. The these extra sets will cover topics in ordered fields, topology of metric spaces and power series that are beyond the scope of 4101. These problems will demand more exposition and will be partly graded on the quality of the exposition.

#### **Tests:**

There will be 8 quizzes and 2 midterm tests. The quizzes will be short and given at the end of the Friday classes. They are designed to test competence in the basic tasks of the course. The quiz content will be announced the class before the quiz. Makeup tests will only be given for emergencies with a written notice and must be taken promptly.

## Math 5101 Advanced Calculus

**Student Learning Outcomes:** After the course students will have familiarity with the basis facts and methods of real analysis. They will be able to read and understand proofs and produce proofs especially of the  $\varepsilon$  -  $\delta$  type. They will understand the topological generalizations of real analysis concepts like continuity and compactness. They will understand the Riemann integral as defined by Darboux sums. They will understand the difference between pointwise and uniform convergence of sequences of functions.
